It is unlikely, under normal working conditions with adequate ventilation, that OSHA exposure levels will be exceeded for residual VCM. However, it is recommended that the user take necessary precautions (e.g. mechanical ventilation, local exhaust ventilation, air-monitoring, respiratory protection, etc.) to ensure airborne levels of any vapors including VCM or dusts that may be released during heating or processing are below regulated levels.
